The One Day Class will be on the repair of electric clock rotors. We will concentrate on the disassembling, cleaning, repairing and reassembling of the rotors for electric clocks as well as testing the coils of various manufacturers. Some of the motors we will work on will be Telechron, Sessions, G.E., United ,Hansen, and Synchron.

Participants should bring a good set of pliers, at least one complete electric clock motor, and whatever tools they think necessary. Remember the last hour of the class will be "Open Bench" where participants can bring any watch or clock problem and receive help in solving the problem or ,at least, the making of sympathetic noises to try to comfort you if we can't. It might be helpful, if you are bringing a problem, to let the Instructor, Dave Gorrell, know in advance. This would allow him to bring whatever parts or tools necessary to help you.

HOROLOGY IN HOLLYWOOD

My last article was about a timepiece that was in the background of a movie. This time I'd like to discuss one in which it is an integral element in the film. This is the case for "Groundhog Day" starring Bill Murray and Andie MacDowell. Phil Connors (Bill Murray's character) keeps re-living the same day over and over. This is evident not only by the repetition of the Groundhog Day festivities, but most of all, by the close ups of his clock radio. It has the flip style numbers that were prevalent in the 70s and early 80s.

Each morning at 5:59 am, he dreads the arrival of 6:00am. The radio turns on and announces "It's Groundhog Day!" Each time that the audience sees the clock radio flip to 6 am it sets the stage for another, of the "same" day. Using a flip style clock radio adds to the drama of the movie. This is because they use slow motion photography to increase the excitement of the event.

Murray's character tries to manipulate each day to his advantage. Eventually he realizes the fruitlessness of his life and concentrates on improving the lives of the other people in the town. When his ordeal is finally over, the audience learns of this from his producer played by Andie Mac Dowell, who shuts off the alarm. Also the radio program announces "Opps!
