As you can see, this watch was gifted by George Washington to Lafayette in honor of the 1781 decisive victory at Yorktown. The watch’s subsequent history is interesting since it was stolen in Nashville during Lafayette’s tour of America in 1824-1825. Many years later it was purchased at a pawn shop in Louisville, Kentucky, and eventually returned in Paris to a grandson of Lafayette.
